OF THOSE, 16 BEDS ARE RESERVED FOR CLIENTS WHO ARE HIV+ AND 53 BEDS ARE RESERVED FOR WOMEN. AN ADDITIONAL 40 BEDS ARE AVAILABLE DURING THE ANNUAL WINTER SHELTER PROGRAM; SINCE 2012, LAMP HAS BEEN SELECTED BY THE LOS ANGELES HOMELESS SERVICES AUTHORITY (LAHSA) AS THE WINTER SHELTER PILOT PROGRAM CHARGED WITH HIGH PSH OUTCOMES AND COMPREHENSIVE DAY SERVICES. 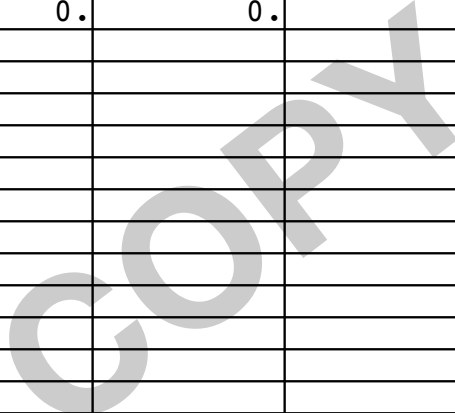
